

Funding opportunities for FE & VET

### Funding opportunities for FE & VET

Every FE or VET provider in the UK is eligible to apply for funding as part of the Turing Scheme.

#### Studies and traineeship mobilities

- 2 weeks (10 work study days) to 12 months
- Studies and traineeship mobility in FE and/or VET providers and/or companies abroad

### Non-participatory attendance at World Skills competition

1 to 10 Days

#### Additional information

- Where duly justified in the application form, mobilities for five days can be run for participants with special educational needs and/or disabilities
- Placements outside of Europe should have a minimum duration of 15 days excluding travel time.

### **Funding opportunities**

An amount of funding will be provided to go towards the general cost of living for each participant.

Participants on a FE or VET placement to any destination will receive:

Group 1 destinations:

£109 per day for the first 14 days, £76 per day after the 14th

Day

Group 2 destinations:

£94 per day for the first 14 days, £66 per day after the 14<sup>th</sup> day

Group 3 destinations:

£80 per day for the first 14 days, £56 per day after the 14<sup>th</sup> day.

An amount of funding will be provided to go towards the direct costs of travel for a placement.

Participants on placements over 19 days to non English-speaking countries will receive £135 per participant to cover expenses such as classroom courses or learning materials to study the language used with the host orangisation.

FE or VET participants from defined disadvantaged backgrounds will receive actual costs for additional travel expenses, including costs of visas, passports, and health insurance.

For participants with SEND, the scheme will fund up to 100% of actual costs for support directly related to their additional needs.

This funding will also cover preparatory visits by the sending organisation to carry out risk assessments and ensure participants will be able to equally access and take part in all elements of a placement.

Pre-visits can be for a maximum duration of three days, and funding can be used for both learners and accompanying staff.

### Why should FE & VET providers apply?

Offer life-changing experiences for your learners and increased exposure to the world beyond their national borders - learning about new cultures and expanding their world view and improving their engagement and confidence.

Provide learners with focused time to gain a deeper understanding of topics they are studying adding relevance to their learning.


Improved engagement in learning and raised aspiration. Experiential learning at its best.

Enhanced relationships and social ability

Greater rapport and personal connections between learners and their peers and the new relationships they form on the visit.

This can lead to increases in learning motivation and collaboration.

Gain access to techniques and skills not widely available in UK industry and gain experience with industry experts.

# Why we bid for Turing Funding!

To broaden the horizons of parochially minded young people whilst improving their employability. We aim to achieve this through students gaining new knowledge, skills, and competences, also building self-confidence and raising aspirations through the opportunity of living and working in another country.

#### POSITVE IMPACT OF BIDDING

#### **COLLEGE RELATIONSHIPS**

Specific learning outcomes should be mapped against the students' Individual Learning Plans through the learner training agreement, which will be agreed with the tutor and student. Input from curriculum areas around your college are paramount to a successful bid.

#### **EXTERNAL PARTNERSHIPS**

Through applying for international projects we feel that the college as a whole is increasing its reputation as an education provider. Along with a high quality education for our students we are able to enhance their programme with a live vocational placement immersed into a new cultural setting. This has seen profound impact on the self esteem, confidence and employability of each and every student who has taken part.

### **EXTERNAL MARKETING**

The success of our Turing Scheme projects has also generated significant attention from outside organisations such as regional press. This will further support the promotional activity of our provision to the next generation of students should our latest bid be successful and has also improved our reputation in the Education sector.



### TURING SCHEME EQUALITY & DIVERSITY

#### **DISADVANTAGED FUNDING**

We have been able to encourage more applications from high needs students who would normally find participation difficult. We support the process of application, the accessibility of travel arrangements and can even provide a personal assistant to support in the work placement. Many of our students have never travelled abroad and often have little experience of travel even around the UK.

The Turing Scheme has helped to ensure our projects are committed to ensuring international opportunities are available to everyone, with applications encouraged from all students regardless of the differing needs and capabilities. Through recognising and valuing student differences we can provide inclusion for all, ensuring there is no unjustified discrimination in our processes for recruitment and selection. Mechanisms to support identified needs are provided throughout the student journey be it in college or whilst on placement.


### HOW TO MAKE INTERNATIONAL PARTNERSHIPS...

#### WORD OF MOUTH

Contact other local colleges and universities to discuss approaching their partners. They may have well-established links that they are happy to involve you in or they could explain how they set up their partnership.

### TWIN TOWNS/CITIES

Contact your local council about twin towns and cities.



#### SOCIAL MEDIA

Social media is also an incredibly useful tool for linking up with overseas colleges and receiving organisations.

LinkedIn is also a particularly handy way to approach new contacts in a more professional capacity.

#### **INTERNET SEARCHES!**

Specific words, phrases and hashtags are an easy way to bring up the contact details of potential new partners.




### EXISTING INTERNATIONAL LINKS...

Many FE & VET providers have global resources that may be going untapped – don't be afraid to use personal contacts. Use any previous connections you may have to see if there is interest in a future partnership.

Students, tutors and even governors may all have international links – don't be afraid to explore these options. Whether that's through reaching out to individuals directly; encourage the wider college community to support you in your partnership search.






### ST. LUCIA, CARIBBEAN



How to apply

### The Turing Scheme application

Applicants will answer qualitative questions under **four** distinct sections

Each section has an allocated maximum possible score (between 20 - 30).

Questions that require a narrative answer have a 500-word limit. Further guidance on what to include in written answers can be found in the Application Guide.

The Application Guide provides you will all the information you will need to gather when planning your application mobility groups

The application will then go through an independent assessment by trained assessors from our partner the Association of Commonwealth universities.

International engagement (Global Britain) 4 questions

Levelling up

2 questions

Positive impact and value for money
5 questions

Design and implementation (monitoring)

2 questions

### Finding an international partner

### Eligible receiving organisations for FE & VET

FE and VET providers can send their Participants to the following receiving organisations outside of the UK:

- any public or private organisation active in the field of further education or vocational education and training
- any public or private organisation active in the labour market or in the fields of education and training.

### Top tips for a successful application

#### Read the programme guide

The programme guide provides all the information you need to check your eligibility for funding and how to apply

Use all the application support resources available

04

#### Structure your thinking

Writing a subheading to introduce different sections within each of your answers will help assessors follow your narrative 02

#### **Know your priorities**

Consider the scoring qualitative criteria when focusing time on application responses

05

#### **Work smartly**

If there is information you would like to provide that you think is relevant to more than one application section, cross reference it instead of copying and pasting the same text multiple times. 03

#### Plan Ahead

Collaborate with colleagues and host partner organisations to create a realistic plan that will deliver your project objectives

06

#### Before you submit

Take a note of your unique application ID and check your application thoroughly

Applications may not be resubmitted - we will accept the first submission of an application only






